- 9) As on 29.12.1998, there will be no permanent grant. (permanently without Aid), the Governing Body Rs.20.00 Rs.23.00, Rs.23.00, Rs.23.00, Karnataka (Yasa), without prejudice to the provisions, of the Educational Institutions (Disclaimer and Control) Rules 1999.
- 10) The examination procedure of principals fixed by the department and the government, etc shall be governed by the festival itself.
- 11) Karnataka Education Act (K3 Act of 1997) within 2 months of approval as per Sen 3 to 31 Re and ED 131 Misc 98 Bengaluru Dated: 04.11.99, Application for recognition and recognition to Swama authorities.
- 12) Government Order No.ED 28 PGC 1994: Date: 29.11.04 for Class 1 to Class 5 Kannada or schools which are conducting children in mother tongue medium and following the language policy have been upgraded to English medium from the striated and registered.
- 13) To start the school a security deposit is to be deposited by the institution jointly with the District Deputy Director and the Governing Body to be kept in account.
- 14) In each permitted class, the attendance of children and teachers should be followed as per rules.
- 15) Employing only trained and qualified teacher as per the rules of the department.
- 16) Medical examination of students should be done as per rules every year.
- 17) Covering provisional accreditation registered under Article 8 of the Karnataka teachers Bill vide sub-section 36-30.
- 18) 22 Working hours and days shall be as per departmental rules.
- 19) The opening of the school and enrollment of students should be reported to this office within two months of the registration of the school or the commencement of the academic year. If the school does not open, and any conditions. The order for automatically cancelled.
- 20) To open the service register of the staff appointed in the school and maintain their service details compulsorily.
- 21) 2015-16 as registered to start 6<sup>th</sup> class (English medium) to start 7<sup>th</sup> and 8<sup>th</sup> karagai based on future growth.
- 22) Kannada medium classes should not be affected in any way by sanctioning English medium senior primary school Taking care of.
- 23) Vide Government Order No. ED 14 PVC of 2002 Dated: 11.05.12 Class 6 - 2015-16 Allowed to launch in media.
